

TERMS AND CONDITIONS

MIKE'S WRECKING INC. WARRANTS MOST PARTS 90 DAYS SUBJECT TO THE CONDITIONS AND LIMITATIONS LISTED BELOW.

WARRANTY STARTS THE DATE OF PURCHASE NOT THE DATE OF INSTALLATION.

ANY WARRANTY CLAIMS MUST BE PRESENTED WITHIN THE 90 DAYS OF PURCHASE DATE.

WARRANTY IS VOID WITHOUT THIS RECEIPT

Transmissions are warranted to function properly in all gears at time of installation by a reputable mechanic known to us. Transmissions must have new seals and new recommended fluid installed at time of installation. Transmission fluid, seals, and gaskets are not warranted. Improper detent adjustment, low fluid level, failure to install new filter, broken front pump, or improper installation voids this warranty. Shearing and breaking of teeth in standard transmissions is NOT warranted under any circumstances.

Transmission cores must be assembled and complete with converters. Transmission cores must be returned within 30 days or core deposits are forfeited.

Engines are warranted against cracked cylinder blocks or heads, bad cam or crankshaft, excessive oil consumption. Engines are warranted to be in good running order unless otherwise stated. All engines are sold with heat sensors installed. This warranty is void if any heat sensor has been activated or removed. Overheated engines are NOT warranted. All engines must upon installation, have new oil, oil filter and timing belt if applicable. Oil to be changed every 3000 miles thereafter (Proof of service and mileage required.) Engines are left as complete as possible for the convenience of the installer. This warranty does not cover attached items and accessories such as (but not limited to) water pump, distributor, carburetor, etc.

Engine cores must be assembled and any accessory part that was included on the engine at time of sale must be included on the engine core. Engine cores must be returned within 30 days or core deposit is forfeited.

Tires, Wheels, and Body Sections are void of a 90 day warranty: they are warranted at time of purchase only.

WE DO NOT GURANTEE LABOR ON DEFECTIVE PARTS NOR DO WE GUARANTEE OUR PARTS AGAINST DEFECTIVE LABOR. IMPROPER INSTALLATION WILL VOID WARRNTY.
